Kathy Retz made a motion to approve previous meeting minutes; Tom Schultz seconded; all in favor motion carried.

Treasurer's Report:

Financials as of year-end were reviewed. Robb Reinker made a motion to approve Treasurer's Report; seconded by Sandy Turner; all in favor-motion carried.

Website:

- Website is up and ready to go; just waiting for the site to be turned on.
- There are three sites available: general public, residents and board members. The latter two are password protected and will require a user name and password.
- Committee gathering email addresses to make the process smoother.

Beautification Committee:

- New furniture has been selected which includes six chairs and three loveseats with wood arms.
- Waiting for samples before determining color.
- Suggestion made to order additional materials to make repairs.

ACC Committee:

- Doing more "business"
- Last week seven items on the agenda which included two new home approvals breaking ground in late March.
- 13th fairway in Village homes with back door to nowhere. Working towards modest deck-10 ft into setback area. Previous homeowners turned down for decks will be notified of change in ACC guidelines

Roofing:

- Sandy Turner moved to use Ken's Parkhill at a cost of \$31,300; seconded by Kathy Retz; all in favor with a cap at \$35,000 to include all incidentals.

Siding:

- Budget and choices discussed
- Decided to replace siding on the whole building with Hardie board by a majority vote
- Additional quotes will be acquired

Doors:

- Back two doors of community building will be replaced on March 8 and 9.
- Acquiring quote to install film on doors once installed

Asphalt:

• Will be done in the spring

Amendments:

Board reviewed two amendments to documents at a cost of \$1065 plus recording fees of \$80:

- Tier 3 Sexual Predator must register with sheriff's department which in turn notifies residents within certain area. Amendment states no Tier 3 sexual predator may live within community for any period of time.
- Use of New Technology Amendment states use of email vs certified mail which is cost saving. Mike Conley moved to proceed with amendments; seconded by Tom Schultz; all in favor motion passed.

Signage:

- Removal of builder signs at Miner and Bishop will be requested
- Open House signs only permitted day of event

Signs:

• 4 street signs will be repainted - East Legend, West Legend, Augustus and Sutherland

Tennis Court:

- Overall In good shape; some minor cracking
- Needs to be powerwashed

• Request for charity gambling event denied

Stonewater:

- Whitney gave update on Rustic Grill including upcoming events
- Requested addresses again for mailings
