Dear Homeowner:

Enclosed please find a copy of the current Community Center Swimming Pool and Tennis Court Rules.

We are pleased to inform you that the Aberdeen Community Swimming Pool will open on Saturday, May 28, 2016 and will close for the season on September 11, 2016, weather permitting. This year the pool will open daily at 11 a.m. and close at 8 p.m.

In order to gain entry to the pool, all residents will be required to swipe their recreation pass through the card reader at the gate.

Under the authority of Association directors, lifeguards are authorized to refuse entry to anyone without valid recreation passes.

If you do not have a recreation pass(es), enclosed is a form that should be filled out and returned to Western Reserve Property Management. Once the completed form is received, your card(s) will be mailed.

If you have a valid recreation pass, you do not need to complete the enclosed application.

Please be reminded that recreation passes are restricted to adults only.
