COMMUNITY CENTER SWIMMING POOL RULES & REGULATIONS

1. The pool opens on Memorial Day Weekend and closes on September 11, weather permitting.
- 2. The pool is open daily from 11 a.m. to 8 p.m., weather permitting.**
3. Use of the pool during pool hours and when the lifeguard is not on duty is reserved for adults only who swim at their own risk.
- 4. Recreation passes are required to be swiped in the card reader located at the gate area in order to gain admittance – no exceptions.**
- 5. Visiting with the lifeguard on duty is prohibited.**
6. The pool will close (at the discretion of the lifeguard) for any inclement weather or for health and safety reasons.
7. An emergency telephone is located in the pool pump room.
- 8. Diving into the pool is prohibited.**
9. Non-swimmers under 12 must be accompanied by a swimming adult.
10. Children five and under must have proper supervision with them at all times. While lifeguards are responsible for the safety of all patrons, they cannot take the place of an adult or supervisor.
11. Individuals wearing approved swim diapers are allowed in the main pool.
12. No pets are permitted inside the fenced area.
13. No bicycles or other wheeled vehicles, except wheelchairs and mobility chairs, are permitted in the pool area. Bicycles are to be stored in the bicycle rack located outside of the pool area.
14. All residents and guests must conduct themselves in a safe manner.
- 15. Residents may bring only two (2) guests to the pool.**
- 16. Alcoholic beverages of any kind are prohibited inside and outside the fenced area. Swimming after the consumption of alcoholic beverages is strictly prohibited.**
- 17. Food is not permitted inside the fenced area. Please use designated eating area with trash receptacles.**
- 18. No glass containers of any kind are permitted in the fenced area.**
- 19. Smoking is not permitted inside the fenced area.**
20. Running, pushing or rough-housing is not permitted in or around the pool.
21. Use of profanity and/or vulgar, sexually or racially offensive language – witnessed by a lifeguard or reported to a lifeguard by an adult – will result in immediate ejection from the pool for the rest of the day and possible review by the Master Association Board of Directors.
22. Verbal or physical abuse of a lifeguard or reckless endangerment of other swimmers will result in immediate ejection from the pool and prohibited re-entry until the matter is reviewed by the Master Board of Directors.
23. Lifeguards have been directed by the Board to request assistance from the Highland Heights Police Department when any situation might threaten or compromise the safety and well being of the lifeguard staff, residents or swimmers.
24. Only Coast Guard-approved flotation devices are permitted, so long as the person using these devices is accompanied by a swimming adult. Floats, toys, beach balls and other non-safety items are prohibited. Please ask the lifeguard if you are unsure whether the item is permitted.
25. Pool furniture is to remain in the enclosed pool area and may not be used elsewhere.
- 26. Between the hours of 6 p.m. and 8 p.m., one section of the pool will be roped off for those residents who would like to swim laps.**
27. Proper swimming attire must be worn at all times.
28. No radios. Headsets only.
- 29. All decisions of the lifeguard are Final.**
